## RENTAL CONDITIONS

- 1) A \$50.00 **non-refundable** application fee must accompany the application. Application fee must be paid in the form of a money order. The application fee must be paid separate from the security deposit.
- 2) A security deposit equal to one month's rent must accompany the application. If the application is rejected, the security deposit will be refunded in full. **Should the applicant withdraw the application, the deposit will be forfeited.** The security deposit must be paid in the form of a money order. The deposit must be paid separate from the application fee.
- 3) Inside nor outside pets are allowed without the consent of the Landlord. If pets are allowed an additional security deposit of \$500.00 per pet must be paid.
- 4) Section 8 or other housing applications will not be accepted.
- 5) The maximum number of people allowed to occupy a dwelling unit is two people per bedroom.
- 6) Minimum term of the lease is 12 months.
- 7) Self employed applicants must supply documentation of income such as tax returns, bank statements or a notarized accounting statement.
- 8) Monthly rent payment should not exceed 30% of the total monthly income.
- 9) Satisfactory reference from present and/or previous landlord (unrelated to applicant) must be obtainable.
- 10) Minimum score on credit report should be at least 550 points unless some verifiable, extenuating circumstance caused a one time problem.
